In consideration of Fly Corporate agreeing to carry the Child as an Unaccompanied Minor, I make the following declaration:</p> <ol style="list-style-type: none"> I confirm I have arranged for the Child to be escorted to the airport by the person identified in section C. The person identified in section C agrees to remain at the airport until the flight has departed. I confirm I have arranged for the Child to be met at the airport by the person identified in section D at the scheduled arrival time for the flight (or any other time as advised by, or on behalf of Fly Corporate). The person identified in section D is aware they are required to produce valid photographic identification before Fly Corporate crew will release the Child into their custody and care. I acknowledge that I am solely responsible for ensuring these instructions are conveyed to, and complied with by, the person identified in section D. In the event the person identified in section D fails to meet the Child at the destination, or in the event Fly Corporate is not satisfied with the identification produced by the person identified in section D, I expressly authorise Fly Corporate to take whatever action they consider reasonably necessary to ensure the safety and custody of the Child including the return of the Child to the airport of departure, and I agree to indemnify and reimburse Fly Corporate for all costs and expenses incurred in doing so. I confirm and warrant that all information provided on this form (including any Special Instructions in section A) has been completed by me and is accurate and complete. Where I have given special instructions in section A of this form, I acknowledge and agree that while Fly Corporate will make reasonable efforts to carry out any special instructions, Fly Corporate shall have no liability for doing so, or for failing to do so, whichever may be applicable. I give specific consent for Fly Corporate to provide or authorise immediate and/or emergency medical treatment to the Child while in Fly Corporate's care. I understand and agree that Fly Corporate will provide the person identified in section D above with information about any immediate or emergency medical treatment rendered to the Child while in Fly Corporate's Care and it is the responsibility of the person in section D above, to inform the person identified in section C.
